THAT by means of a decree, given on 10th December, 2025, and with reference to the application bearing number 1240/2025, the Court of Revision of Notarial Acts, declared that the Notary Dr Eugene Montanaro stopped exercising his function as a notary.

Illi konsegwenza tal-fatt illi n-Nutar Dott. Eugene Montanaro waqaf milli jeżerċita l-funzjoni tiegħu bħala nutar, il-Qorti tar-Revizjoni tal-Atti Nutarili, hatret lin-Nutar Ewlieni tal-Gvern Dott. Keith Francis German, bħala nutar konservatur tal-atti tan-Nutar Dott. Eugene Montanaro.

That as a consequence of the fact that the Notary Dr Eugene Montanaro stopped exercising his function as a notary, the Court of Review of Notarial Acts, appointed the Chief Notary to Government, Dr Keith Francis German, as notary conservator of the Acts of Notary Dr Eugene Montanaro.

Illi bl-istess digriet datat 10 ta' Diċembru, 2025, il-Qorti tar-Revizjoni tal-Atti Nutarili, ordnat lin-Nutar Ewlieni tal-Gvern, Dott. Keith Francis German, sabiex inizzel l-isem tan-Nutar Dott. Eugene Montanaro fil-lista tal-ismijiet tan-nutara li ma humiex jeżerċitaw il-funzjoni tagħhom.

That by the same decree dated 10th December, 2025, the Court of Revision of Notarial Acts, ordered the Chief Notary to Government, Dr Keith Francis German, in order to list the name of Notary Dr Eugene Montanaro in the list of names of notaries who are not exercising their function.
